Sir/ Madam,

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter No 4-7 MARBH/NCH/2025-26(115-73)/3237-3244 dated: 19.06.2025 to Shalintai Meghe Homoeopathy Hospital College and Research Center Wanadongri, Hingna, Nagpur, Maharashtra 441110 has filed an appeal to the commission against the decision of MARBH vide their letter no SMHHC&RC/NGP/2025-26/71 dated: 04.07.2025

Commission has recommended MARBH vide letter no. 30-5/2025-26/NCH-GR (42)/ 3771, dated: 21.07.2025 for the continuation of permission for 100 seats for 1st BHMS course to Shalintai Meghe Homoeopathy Hospital College and Research Center Wanadongri, Hingna, Nagpur, Maharashtra 441110, for the academic year 2025-26. Accordingly, MARBH is granting **Conditional Permission for 100 seats for BHMS Course for the academic year 2025-26** based on the following conditions:

- College shall submit on- boarding on AEBAS portal and regular marking of the attendance of the staff on the portal, availability of all the requirements for dissection room as per MES 2024 and the experience certificate of the professor appointed in the Department of Materia Medica within one month failing which permission may be withdrawn for the academic year 2025-26.*
- compliance report needs to be submitted for the availability of the infrastructure and required area of the college and hospital as per MES 2024.*

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn in the subsequent year if college is found deficient in compliance to MES-2024 anytime during the academic year.
